## Information for families of Children and Youth with Special Healthcare Needs (CYSHCN)

### COVID-19 Vaccines for Children and Youth with Special Healthcare Needs (CYSHCN)

The American Academy of Pediatrics (AAP) recognizes that children and youth with special health care needs (CYSHCN) may be at increased risk of serious illness and complications resulting from COVID-19 infections, and they recommend that all children eligible for the COVID-19 vaccine get it as soon as they are able, including CYSHCN. The vaccine, along with face masks, cleaning hands and surfaces, and physical distancing are the tools that can be used to prevent infections. In addition to the COVID-19 vaccine, the AAP recommends that CYSHCN continue to receive their [routine vaccines on schedule](#), including the seasonal flu vaccine when it becomes available to them ("[COVID-19: Caring for Children and Adolescence with Special Health Care Needs](#)," 2021). Additionally, the AAP recommends that any child eligible for the COVID-19 vaccine booster get it as soon as they are able ("[When Can Children Get the COVID-19 Vaccine?](#)", 2022). If families have additional questions or concerns about their child receiving the COVID-19 vaccine or any recommended vaccine, they should schedule an appointment with their child's physician for more information.
