

# **Respite Care**

## What is Respite?

Respite is a service providing caregivers an opportunity for rest and relief from caregiving duties. Depending upon a variety of eligibility factors, individuals with special health care needs and their families may have different respite options.

### Respite via Home and Community Based Services (HCBS)

Respite may be accessed as a waiver service through various HCBS programs, including:

- Aged and Disabled Waiver\*
- Traumatic Brain Injury Waiver\*
- Community Integration and Habilitation Waiver\*
- Family Supports Waiver\*
- Child Mental Health Wraparound Program (CMHW)\* and Children's Mental Health Initiative (CMHI)\*

Once the individual with special needs has been targeted for HCBS, respite may be available as a waiver service. The waiver case manager will provide a list of providers and information about the service. Typically, this type of respite cannot be used during a parent's work or school hours.

#### **Respite Funded by Medicaid**

Individuals receiving Medicaid services and who have a need for skilled care may be able to access periodic respite via a nursing facility. This will require a doctor's order and a screening process. This type of respite is also limited.

#### Local Respite Programs

Respite may be available from local providers, such as churches (especially those with disability ministries), Easterseals Crossroads: <u>https://www.easterseals.com/support-and-education/for-caregivers/respite-care.html</u>, and other service organizations.
